2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5
MODES OF CONDUCTING THE PROGRAMMES

1. The programmes will be conducted in in-person/online or offline mode.

Article 6
DURATION AND TERMINATION

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for a period of 5 (five) years and may be extended for another period of 5 (five) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of termination.
- 4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 7
AMENDMENT

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.

Article 8
SETTLEMENT OF DISPUTES


Any disputes concerning the interpretation/s and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.

AMENDMENT


- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
